

**TERMS & CONDITIONS**  
**ADELAIDE ECONOMIC DEVELOPMENT AGENCY | RUNDLE MALL**

**How to Enter**

To enter:

1. Customers who present receipt(s) showing a minimum spend of \$50 on retail purchases or \$50 on dining purchases, including restaurants, cafés and takeaway retailers (excluding supermarkets). Eligible participating venues are determined at the discretion of Rundle Mall.
2. Visit the 'Shop, Dine, Spin' activation located in front of Rundle Place in Rundle Mall, sign up to the Rundle Mall mailing list and agree to these Terms and Conditions.
3. Present proof of purchase (receipt/s) to promotional staff for the chance to spin to win a \$10, \$20 or \$50 Rundle Mall Gift Card.
4. Spin the promotional prize wheel to determine whether they have won a \$10, \$20 or \$50 Rundle Mall Gift Card or have not won a prize by landing on a 'No Win'.
5. Customers are permitted one (1) prize wheel spin per person, per day.
6. Eligible purchases must be made on the same day as entry into the promotion.
7. Customers who present receipt(s) showing a minimum spend of \$50 on retail purchases and \$50 minimum on dining purchases, in a single day during the promotional period, will receive two (2) entries into the major prize draw.

- Saturday 27 June 2026 from 11:00am – 2:00pm

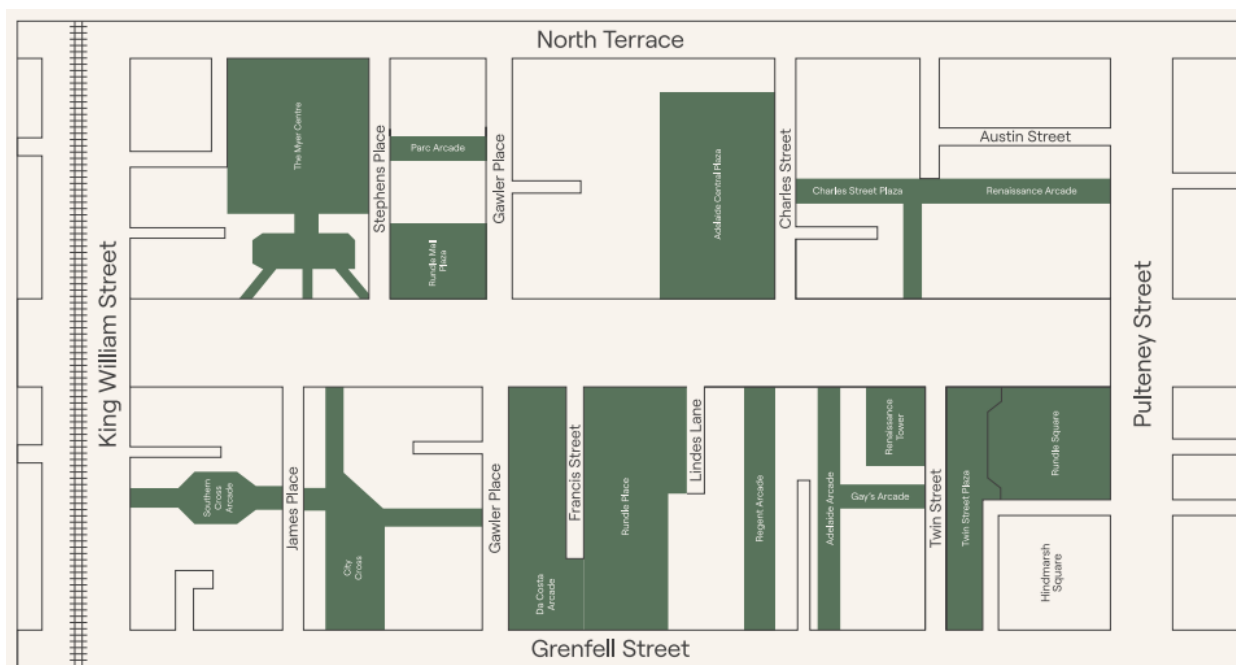
Entries are only valid during the promotional hours listed above.

## Conditions of Entry

12. Information on 'how to enter' forms part of these 'Conditions of Entry'.
13. Customers who present eligible receipt(s) totalling a minimum spend of \$50 from either retail or dining within the Rundle Mall Precinct are entitled to one (1) spin per day.
14. Customers who present eligible receipt(s) showing a minimum spend of \$50 on retail purchases and \$50 on dining, within the same day during the promotion period, will receive two (2) entries into the major prize draw.
15. Limit one (1) spinning wheel attempt permitted per person each day.
16. Each eligible entry must be supported by valid receipt(s) from participating retail and/or dining stores within the Rundle Mall Precinct. Purchases must be made during the promotion period.
