How to Enter

To enter this Promotion, eligible individuals must, during the Promotion Period, simply:

- Make a purchase of \$150 or more in one single day at any businesses located within the Rundle Mall Precinct (see map below) on Friday 9 October 2026 to Sunday 11 October 2026.
 - Visit the Rundle Mall Gift With Purchase activation, located at the Gawler Place Intersection in Rundle Mall.
 - Scan the QR code to sign up to the Rundle Mall mailing list
 - Present your physical receipts for proof of purchase to the staff to have your receipts verified and stamped. Receipt/s presented must be for purchases made on the same day as prize redemption from the Rundle Mall Gift With Purchase activation.
 - Collect a token from the staff and exchange the token at the claw machine to redeem your selected prize.
 - All entrants who enter the competition will receive a prize, all prizes consist of a gift card valid within the Rundle Mall Precinct and are while stocks last.
3. Persons under the age of 18 years old are permitted to enter the promotion provided parental/guardian consent is obtained.
 4. It is a condition of entering the Promotion that entrants agree for their personal information to be added to the Promoters database and to be used in accordance with the purposes set out in these Terms and Conditions.

Limits on Entry

5. Customers can only enter once per day into the competition. Subsequent entries by the same customer within the same day as original entry will not be allowed.
6. There is a limited supply of gift cards available each day during the Promotion Period, and there is potential for the daily prize allocation to be exhausted. 13. Receipt must be fully legible and be from a business within the Rundle Mall Precinct.

21. Receipts from lotteries, gift cards, prescriptions, tobacco or liquor cannot be presented as receipts to enter.
