

## **TERMS & CONDITIONS CITY OF ADELADE - RUNDLE MALL**

### **How to Enter**

To enter the customers simply:

5. Receipts must be fully legible and be from a participating store(s) within the Rundle Mall precinct.
6. Customers are required to retain their receipts to be presented if claiming a prize.
