Terms & Conditions**

1. These terms and conditions are for all entrants who enter the Rundle Mall Social Club Promotion ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The "Promoter" is Adelaide Economic Development Agency (ABN: 76 182 348 392). The address is Level 1, 5 Pirie Street, Adelaide 5000

How to Enter

To enter this Promotion, eligible individuals must, during the Promotion Period, simply:

- Make a purchase of \$150.00 or more (to receive one entry) at any businesses located within the Rundle Mall Precinct (see map below) on Friday 10 October 2025 to Sunday 12 October 2025.
 - Visit the Rundle Mall Social Club activation, located at the Gawler Place Intersection in Rundle Mall.
 - Scan the QR code to sign up to the Rundle Mall mailing list
 - Present your physical receipts for proof of purchase to the staff to have your receipts verified and stamped. Receipt/s presented must be for a transaction dated as the same date it is presented at the Rundle Mall Social Club activation.
 - Enter your desired vending machine PIN and select one envelope to redeem that prize.
3. Persons under the age of 18 years old are permitted to enter the promotion provided parental/guardian consent is obtained.
 4. It is a condition of entering the Promotion that entrants agree for their personal information to be added to the Promoters database and to be used in accordance with the purposes set out in these Terms and Conditions.

Limits on Entry

5. Customers will be able to enter more than once into the competition, provided they spend an additional total of \$150.00 in a single day and follow the steps above each time.
6. There is a limited supply of gift cards stocked in the vending machine each day during the Promotion Period, and there is potential for prizes to be exhausted each day. Prizes are available on a first in, first serve basis and will no longer be available to eligible entrants who make purchases on day when prizes are exhausted.
7. If entrants cannot make it to the Rundle Mall Social Club within the opening hours, regardless of their total spend, they are not eligible to win a prize.

Duration of Competition

The competition opens at 10:00am ACST, Friday 10 October 2025 and closes 5:00pm ACST, Sunday 12 October 2025.

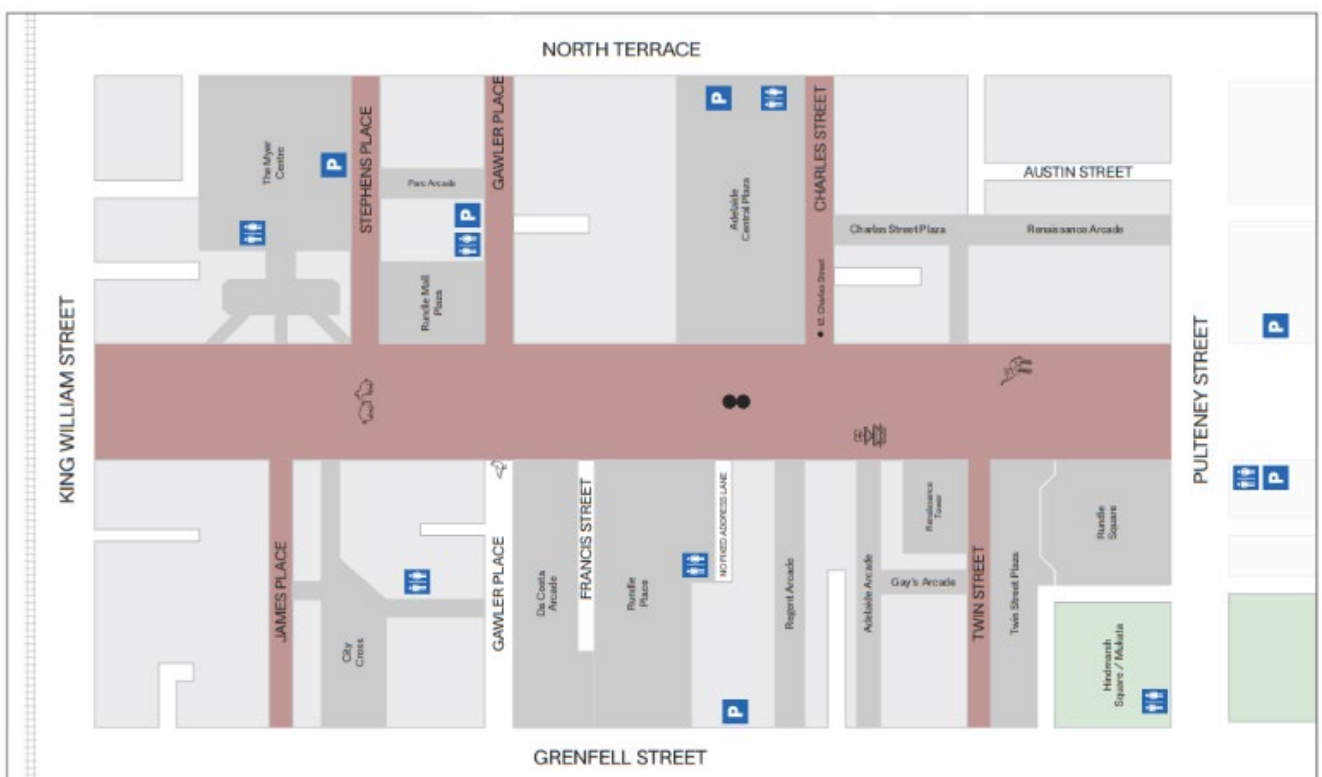
Conditions of Entry

8. Information on 'how to enter' forms part of these 'Conditions of Entry'.
9. Customers may receive one entry per \$150.00 spent within the Rundle Mall Precinct on the corresponding day of competition entry.
10. Each entry requires proof of purchase in the form of a receipt from a business within the Rundle Mall Precinct. The purchase must have been made during the promotion period and date shown on receipt must match the corresponding competition entry date.

11. Each eligible entry must have receipt(s) totalling minimum spend of \$150.00 accumulated within one (1) day.
12. Customers may enter more than once, but each entry requires proof of purchase(s) in the form of receipt(s) from a store(s) within the Rundle Mall Precinct. The purchase(s) must have been made in the same day as the competition is entered.
13. Receipt must be fully legible and be from a business within the Rundle Mall Precinct.
14. Entries received after the close date will not be considered.
15. Entries will not be accepted via post, they must be made in-person at the Rundle Mall Social Club.
16. Entries illegible, forged, mutilated, copied, or tampered with in any way will not be considered.
17. Employees of the City of Adelaide are ineligible to enter.
18. Management and staff of businesses in Rundle Mall are permitted to enter as long as they do not present receipts from their place of employment.
19. Receipts from partial lay-bys, bill payments such as the payment of credit card bills, bank transactions, bank fees and charges and service bills [such as gas, electricity, rates and phone bills] cannot be presented as receipts to enter.
20. Receipts from lotteries, tobacco or liquor cannot be presented as receipts to enter.
21. The person collecting the prize must provide suitable identification to the promoters' satisfaction to be entitled to claim the prize.
